 3. Essays should be no more than 200 words in length.
 4. Name, address, age, date of birth and other details (where applicable) must be clearly printed on the entry form and then attached to the back of the entry. Any entries bearing incomplete entry forms will not be considered.

It should be noted that once the entries are received by the credit union they become the property of the credit union and may be reproduced at the credit union's discretion and may only be returned at the discretion of the credit union. All entries are accepted as original works and the credit union is not responsible for any breach of copyright.
 6. Entrants may enter the Contest only once.
